## Pope Francis New Laws Mandating the Reporting of Sexual Abuse

Pope Francis has issued new global rules for reporting sexual abuse in the Catholic Church, mandating for the first time that all diocese set up systems for reporting abuse. The new rules require all Catholic Diocese around the world to have a 'public and accessible' system in place for reporting abuse by 1 June 2020.

The Australian Catholic Bishops Conference has welcomed Pope Francis' new document on the investigation and reporting of abuse within Church settings. *"The release of this document less than three months after the meeting shows that, for Pope Francis, the updating of universal Church law on the investigation and reporting of abuse against children and other vulnerable people is a real priority. It's a priority the Australian bishops share. Now all bishops conferences and religious congregations around the world will have to meet more rigorous standards. That's a good thing."* Archbishop Coleridge said.



## Code of Conduct for Young People (CCYP)

The Safeguarding Team and Sydney Catholic Youth are excited to announce a new initiative that we want you and your Youth Ministry Group to get involved in. The Archdiocese would greatly appreciate your help to create of a Code of Conduct for Young People (the CCYP).

What could possibly be better than empowering our very own Catholic Youth to help make decisions that affect them? Together with the Youth Group Leaders, your young people can help to make their own rules and regulations when attending a Youth Ministry Group within the Archdiocese of Sydney.

## 10 National Principles for Child Safe Organisations

In February 2019, the 10 National Principles for Child Safe Organisation were endorsed by members of the Council of Australian Governments. The National Principles reflect the 10 Child Safe Standards recommended by the Royal Commission into Institutional Responses to Child Sexual Abuse. The principles aim to provide a consistent approach to creating organisational cultures that foster child safety and wellbeing.



The Archdiocese of Sydney has already started to implement the 10 National Principles. In doing this the Archdiocese of Sydney is demonstrating leadership and commitment to child safety and wellbeing.

Child sexual abuse is a crime. The appropriate people to deal with crimes are the police. If you, or anyone you know, have been abused, please contact the police. You may also want to speak to your Parish Priest who will be able to provide support and guidance. The Archdiocese has a legal obligation to report crimes to the police.

## Introducing... Fr Hamilton Ureta, Parish Priest of Our Lady of Fatima Kingsgrove

## Introducing... Gayle Anderson PSSO for St John Bosco Engadine

*"Hello, my name is Gayle Anderson and I am one of the PSSOs in our Parish of St John Bosco Engadine, and for me it's a real privilege to be involved in this ministry. Two years ago we developed a Vision Statement to focus and guide the Safeguarding pathway for our parish community: ....to ensure that the young and the vulnerable are welcomed cherished and protected to worship and grow in Christ.*

*Children are a delight in our families and in our communities, and have a very important place in our parish. We celebrate and follow their growing faith through their sacramental journey; they are the life and focus of our schools; and their energies and initiatives play a vital role in many of our parish activities and ministries.*

*Our PSSO team strive to encourage all parishioners to pray for a deepening sense of community and aspiring to Our Lord's command: love one another as I have loved you (John 13:34-35), that is, to be a loving community, offering a welcoming environment in which people can flourish, and be safe from harm."*



## Role of the PSSO

The Safeguarding Office would like to acknowledge you all for the commitment you have made ensuring that your parish environment is safe for our children, young people and vulnerable adults.

As you are aware the role of the PSSO is to support and assist your Parish Priest in his Safeguarding responsibilities, to ensure the Archdiocese of Sydney Policies and Protocols are established and maintained to create safe environments in the parish. It has recently come to the attention of the Safeguarding Office that PSSO's in Parishes are being asked or getting involved in dealing with complaints. It is not the role of a PSSO to be dealing with any complaints; all complaints need to be referred to either the Parish Priest or the Safeguarding Office.

The Safeguarding Office has developed a position description specifically for PSSO that identifies the tasks that PSSO's have been trained and certified to perform. The position description can be found on the [Parish Intranet](#) under the PSSO heading.

## PSSO Development Day
