

Welcome to the Safeguarding Office's Quarterly Newsletter!

The Safeguarding Office is very excited for Child Protection Week which will take place from **6 September to 13 September 2020.**

This will be the fifth year the Catholic Archdiocese of Sydney has promoted and engaged with Child Protection Week which was initiated 30 years ago by the <u>National Association for the Prevention of Child Abuse and Neglect</u>. This week provides us with a great opportunity to think about how we can work together to keep all children safe.

As the Blessed Virgin Mary's birthday falls during Child Protection Week on 8 September, we have asked for her motherly intercession during this week for all Children throughout the world and for our work in the Safeguarding Office.

You might remember that in May, the Safeguarding Office sent out a CyberSafety Survey in response to an increase in enquiries related to online safety. We thought the findings of the survey would be a great opportunity to develop resources that would help adults, children and young people stay safe online which could be launched for Child Protection Week.

The results of the Survey were very informative and we were overwhelmed with the large response we received. We want to extend a huge thank you to all those who took part in the survey.

From the results, we have developed a range of new resources which will be launched on 6 September 2020 for Child Protection Week. Please keep an eye out on our website for their release.

Information Packs will also be sent out to our Parish Priests which contain helpful information for the launch of Child Protection Week.

New Online Refresher Safeguarding and Child Protection Training

It is mandatory within the Archdiocese and a requirement in terms of meeting our obligations under the National Catholic Safeguarding Standards (Standard 7), that every three years employees complete refresher Safeguarding Training.

We have launched new *Online Refresher Safeguarding and Child Protection Training* on our online platform, to make it easier for workers to be able to complete this training.

A big thank you to all of those who contributed to these sessions by actively participating and sharing wisdom - you are helping to make the Archdiocese a safer place for children and vulnerable adults.

We are kindly asking that all Parish Priests, Administrators and Agency Heads ensure that their employees who completed the *Level 1 Safeguarding Training for Parish Staff* three years ago register for the *Online Refresher Safeguarding and Child Protection Training*. Safeguarding Face-to-Face Training Postponed

The Safeguarding Office takes the safety and welfare of all clergy, employees and volunteers seriously so it is with great disappointment that the Safeguarding Office has to inform you that due to the Coronavirus (COVID-19) situation, ALL face-to-face Safeguarding Training has been suspended until January 2021.

Parish, Chaplaincy and Agency Self-Assessments

We want to thank you so much for taking the time to complete your Parish, Agency or Chaplaincy Self-Assessment. A lot of hard work and time went into answering them and many of you have even started to action the items listed on your Continuous Improvement Plan, which is fantastic! There are currently 8 Parishes out of a total of 146 that still need to return their completed Self-Assessment. We ask that you return them by 28 September 2020 at the latest. Feel free to contact us should you need any assistance - we are more than willing to help you work through each step.

The Self-Assessments are used to help you determine if you are meeting the standards of <u>Catholic Professional Standards Limited</u> (CPSL). They reflect the audit format of CPSL so that when they audit you in the future, you will be familiar with the layout and will have already implemented a number of requirements. New Risk Assessment Documents

A new policy document, Policy: Risk Assessment Policy Guidelines, has been developed to help you understand the purpose and processes involved in completing Risk Assessments. Please take the time to review this document so you can better understand why and how we should be completing Risk Assessments.

To help promote continuous improvement throughout our Archdiocese, a new document titled, Evaluation and Continuous Improvement, has been developed to help you identify where improvements can be made in your Risk Assessment mitigation strategies.

After the activity has been completed, you will then be able to review the mitigation strategies you listed, to see how effective they actually were in mitigating the identified risks. If you later realise that there was more that you could have done to mitigate actual and potential risks, this document will help you to be better prepared for next time. Special Religious Education (SRE) Safeguarding Induction Training

The Confraternity of Christian Doctrine (CCD), has developed a new Special Religious Education (SRE) Safeguarding Induction Training Certificate. After the completion of Safeguarding training with the CCD, this certificate will be issued to attendees as evidence of having completed their training.

The certificate will have a record of when the training was completed. A copy of this certificate can then be provided to your Parish Priest or Parish Safeguarding Support Officer (PSSO) along with your signed Code of Conduct.


Catechists who have completed the Safeguarding Training provided by the CCD, **do not** need to complete Parish Safeguarding Induction Training in addition to this.

The Safeguarding Office fully supports this initiative by the CCD and hopes that it will help to clarify some of the requirements around training.

Safeguarding Commitment Statement

We are all on a journey together to help make our Archdiocese a safer environment for children. Standard 1.1.2 of the CPSL Child Safeguarding Standards requires that we publish "...a Child Safeguarding Commitment Statement which is openly displayed and publicly available".

A way you can implement this standard and demonstrate commitment to safeguarding children is by displaying a commitment statement on your websites, bulletins, newsletters or signature blocks. Feel free to choose a platform that best suits your Parish, Agency or Chaplaincy.

The following text is an example of a commitment statement which we recommend for you to use:

"The Catholic Archdiocese of Sydney upholds the dignity and rights of all children and is committed to ensuring their safety. We recognise each child as a gift from God, and we value and encourage the participation of children in all activities that enhance their spiritual, physical, emotional, intellectual and social development."

We appreciate your support on this journey and for helping us to comply with the relevant regulatory bodies.

We request that all Priests of our Parishes display the Safeguarding notice below in all future parish bulletins.

A message from the Archdiocese of Sydney:
